Sir,

In producing herewith one arrested accused person namely Prasanta Bauri (24 yrs) S/o-Sankar Bauri of Vill-Joypur Bauripara, PS- Joypur Dist- Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 14 (Fourteen) bottles Illicit country spirit "DIL SE" strength 80 up measuring 600 ML each bottles of Rs. 35/- out of which one bottle taken as sample under proper seizure with label & 08 pieces plastic glass.

I SI Abhijit Singha of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (29/05/2020) at about 12:45 hrs when myself along with JC/-1068 Amit Rajak, JC/-578 Asish Rout were performing special mobile duty, as per my source information I reached at Joypur Bauripara under Joypur PS and found that the above noted accused person selling Id liquor in his dwelling house. On seeing Police persons, he conceal his presence at that house, but on searching we able to trace out him and also to found that 14 (fourteen) liters of DILSHE Illicit Liquor which was kept conceal at his house. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit country spirit liquor to the local people in his house at Joypur Bauripara. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 13:05 hrs to 13:15 hrs & label duly signed by him and other available witness after taking 01 bottle as sample.

During further interrogation he confessed his guilt as such I arrested him today 29/05/2020 at 13:25 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Prasanta Bauri (24 yrs) S/o-Sankar Bauri of Vill-Joypur Bauripara, PS- Joypur Dist- Purulia, State-WB U/S-46A (c) of the Bengal Excise Act 1909.
