With due respect I SI Susanta Kr Pathak of Joypur PS, beg to submit before you that on 05/05/2020 at about 21:35 hrs while myself along with force were performing night mobile duty vide Joypur PS GDE No-227/20 Date-05/05/2020 & CC No-1837/20 Date-05/05/2020 and found the following persons with his Motor Cycle, were roaming aimlessly at Hargara village more, Police party detained them at Hargara village more under Joypur PS. On being asked the following persons could not able to give any satisfactory answer for that movement on road and public place. On enquire it revealed that the persons are the inhabitant of Jhalda PS area and without any valid reason/valid pass they was moving at Hargara village more. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 103-CS/2020 dated 04/05/2020 which is extended till 17.05.2020. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spared infection of disease dangerous to life. Accordingly the following persons were arrested and seized 01 motor cycle from today (06/05/2020) at midnight about 01:35 hrs. to 01:55 hrs under proper seizure list duly singed by the witnesses and the accused persons, after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to P.S.
