Sir,

In producing here with 03 (Three) arrested accused namely 1.Biswajit@Baghu Bauri(20),s/o-Jahar Bauri,2) Goutam@Chhata Bura Bauri(24),s/o-Lt Madhab Bauri,3.Rakesh Bauri(22)s/o-Hitlal Bauri all of vill-Rambani, PS-Kashipur, Dist-Purulia along with Memo of Arrest.

1 SI Dharanidhar Pandey of Kashipur PS do here by lodged a complaint against above noted 04 accused persons to the effect that on 17.05.2020 at about 17:05 hrs as per direction we were engaged for implementation of Govt. rules regarding lock down Disaster Management plan that found 10-12 persons gathered infront of Gamarkuri bridge Kashipur-Purulia Main Road . After seeing the police party 08-09 persons consist of their fled away. Above noted persons also tried to flee away but after reaching the spot we managed to detain 03 persons. On being asked the following persons could not be able to give any satisfactory answer for that gathering on the road or they could not be able to give reasonable ground for this gathering. So there is every reason to believe that the said three persons came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases. dangerous to life and violated Quarantine rule. So, I arrested the above noted 03(Three) accused persons, brought them to P.S. I offered them for medical treatment but they denied.

Hence I therefore pray that a specific case may kindly be started against above mentioned persons U/S-188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
