Sub: Request for lodging F.I.R. against arrested accused Bijay Majhi & one another...

Sir,

In producing here with 02 (Two) arrested accused namely 1.Bijay Majhi(25),s/o-Lt Bishnu Majhi,2) Parimal Majhi(20),s/o-Atul Majhi both of vill-Khairani,PS-Adra,Dist-Purulia along with Memo of Arrest, one seized motor cycle and seizure list

I SI Anirban Dutta of Kashipur PS do here by lodged a complaint against above noted 02 accused persons to the effect that on 11.05.2020 at about 17:25 hrs as per direction we were engaged for implementation of Govt. rules regarding lock down Disaster Management plan that found 10-12 persons consisting of their 5/6 Motorcycle gathered infront of Gamarkuri bridge Kashipur-Purulia Main Road. After seeing the police party 08-09 persons consist of their respective 4/5 Motorcycle fled away. Above noted persons also tried to flee away but after reaching the spot we managed to detain 02 persons and one motor cycle having REgd No-WB82D/0973 Hero Glamour. On being asked the following persons could not be able to give any satisfactory answer for that gathering on the road or they could not be able to give reasonable ground for this gathering. So there is every reason to believe that the said two persons came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested the above noted 02(Two) accused persons and seized the above Motor cycle with proper seizure list, brought them to P.S. I offered them for medical treatment but they denied.

Hence I therefore pray that a specific case may kindly be started against above mentioned persons U/S-188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
