But he disobey the advice of MO Puncha BPHC and wandering here and there aimlessly .As per information, Myself along with force had been to Jambaid village to work out the information . After reaching at the house of Subhas Sarkar and staying at his house in between 17:15 hrs. to 18:25 hrs. and found he was not available at his house .I asked the family members where abouts of Subhas Sarkar. But they did not give any information about his present where abouts. During local enquiry from the villagers it could be learnt that after returning at his house he left for , wandering here and there aimlessly and meet with his nearest friends . The villagers requested to Subhas Sarkar for staying at his home several times but he did not care to any one which may violating govt. order in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-I (A) Date - 24/03/2020 and further modified order dated -25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 31.05.2020 and the accused person also tried negligently to spread infection of disease which dangerous to human life.

Hence I pray that kindly treat this as FIR as per law and arrange for its investigation.
