In producing here with one arrested accused person namely 1) Mihir Gope (28) S/O Lt. Arjun Gope of village Darodih P.S Kenda dist- Purulia to the effect that today (06/05/2020) at about 20:45 hrs, while I, SI Bapan Mondal S/O Ashoke Kumar Mondal of Vill - Jhaukhali P.S - Bagdah Dist- North 24 PGS at present posted at Kenda P.S as S.I Of Police along with ASI Tanmoy Chatterjee and force were performing mobile duty, found some persons assemble at Daroddih high School Ground and gathered approx 8/10 persons at the Spot without maintaining social distance and violating govt. order in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-I (A) Date - 24/03/2020 and further modified order dated - 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. we reached at the spot and arrested above noted aced. Person and others able to fled away. On being asked the arrested accused persons could not able to give any satisfactory answer for their assemble at the spot at that time. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak, vide above noted order number. The accused persons also tried negligently to spread infection of disease which dangerous to human life.

During enquiry it could learnt that the arrested aced. Person along with 1) Satyajit Gope S/O Paban Gope of village Darodih 2) Bivishan Gope S/O Sraban Gope of village Lepodih 3) Nirmal Mahato S/O Bhiswa Mahato of village Bhandarpuara 4) Ashoke Gope S/O Hariram Gope of village Darodih all of P.S Kenda Dist- Purulia and others were assemble for enjoining party. During enquiry the arrested aced person suppressed the others aced. Persons who fled way from the spot.

Hence I pray that kindly treat this as FIR as per law and arrange for its investigation.
