Sub: Prayer for starting a specific case under proper section of law.

Sir,

In producing herewith one seized Truck bearing No -WB 53B/7439, Engine-61C84293465 & Chassis No-MAT466429GHC05236 loaded with raw coal of 12 M.T. (approx) do hereby lodge a complaint to the effect that on (07/05/2020), I, SI Bablu Ghosh along with (1) C/1140 Dayamoy Mahato (2) C/480 Uttam Bouri and (3) C/1260 Santosh Saren all of Neturia PS were engaged in evening mobile duty vide Neturia PS GDE No- 268 Dt. 07.05.2020 & CC No- 1270/2020 Dt. 07.05.2020. In course of evening Mobile Duty, at about 20:05 hrs when we reached near Parbelia Bazar, I received an credible source information to the effect that one Truck bearing No- WB 53B/7439 loaded with illegal coal coming from Asansol side and will transport the same to Raghunathpur side through Purulia - Barakar road in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately rushed towards D. Ghat and started Naka checking there immensely to intercept the above noted vehicle. After some time found one truck is coming from Asansol side, suddenly the vehicle stopped about 90/100 meter away from us and one person seems to be the driver of the vehicle got down from the vehicle and started running towards dark side beside the road. We chased the person but in spite of hot chase he managed to flee away. We searched the surrounding area with torch light to find out the person but failed to trace out him. On search we found that the vehicle (Truck) bearing no -WB 53B/7439 is loaded with raw coal of 12 M.T. (approx) and the key of the vehicle has been left away in the vehicle by the driver.

So, there is reason to believe that the driver, owner of coal and registered owner of the said vehicle have collected the said coal either by theft or by any fraudulent means and tried to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.

Accordingly I seized the said truck bearing no – WB 53B/7439 loaded with raw coal of 12 M.T. (approx) under proper seizure list duly signed by the Police witnesses in between 20.45 hrs and 21.05 hrs, since no public witness was found as well as seized approx 05 kg raw coal from the above noted seized truck as sample and labeled the same.

Under the above circumstances a specific case may kindly be started against the (1) driver of truck bearing registration No – WB 53B/7439 (2) owner of the coal, seized from truck bearing registration No – WB 53B/7439 and (3) Registered owner of truck bearing registration No – WB 53B/7439 under proper section of law.
