Complain to start a specific case. Sub:

In producing herewith 06 (Six) arrested accused persons namely (1) Ram Prasad Pandit (38) S/O-Lt. Ashok Pandit of Vill-Saltore (2) Pintu Pandit (26) S/O- Lt. Tapan Pandit of Vill-Saltore (3) Pravas Chandra Pal (45) S/O- Manik Chandra Pal of Vill-Saltore (4) Amit Kumar Mahato (20) S/O- Rabindra Mahato of Vill-Parbelia Colliery Amdanga (5) Sashi Kumar Ram (23) S/O- Kishore Ram of Vill-Parbelia Colliery Amdanga and (6) Manoj Choudhary (23) S/O- Rajendra Choudhary of Vill- Parbelia Colliery Amdanga all under PS- Neturia, Dist-Purulia with seized two motorcycles i.e. (1) Hero Glamour Motor Cycle bearing registration No-WB 82A/6342 and (2) Honda Shine Motor Cycle bearing registration No-WB 82C/6435. I beg to submit that during special mobile duty as per direction we were engaged for implementation of Govt. rules regarding lock down Disaster Management plan. At about 17:55 hrs today on 15.05.2020 when I along with force reached at Parbelia Bazar (Purulia-Barakar Road) under Neturia PS and found that 02 (Two) motor cycles with 02(Two) rider along with 02 (two) pillion riders in each motorcycles were plying from Parbelia new colony side and all were making Halla on road. I intercepted them and also apprehended and on being asked the above noted persons could not able to give any satisfactory answer for their movement on road and public place. So there is every reason to believe that the above noted 06 (Six) accused persons came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia as well as in the state in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested the above noted 06 (Six) accused persons. During the time of arrest maintained all formalities regarding arrest and seized the Motorcycles with proper seizure list duly signed by the police witnesses as no public witnesses appeared to put sign.

Therefore, I pray a specific case may kindly be started against 06(Six) arrested accused persons namely (1) Ram Prasad Pandit (38) S/O- Lt. Ashok Pandit of Vill-Saltore (2) Pintu Pandit (26) S/O- Lt. Tapan Pandit of Vill-Saltore (3) Pravas Chandra Pal (45) S/O- Manik Chandra Pal of Vill-Saltore (4) Amit Kumar Mahato (20) S/O- Rabindra Mahato of Vill-Parbelia Colliery Amdanga (5) Sashi Kumar Ram (23) S/O- Kishore Ram of Vill- Parbelia Colliery Amdanga and (6) Manoj Choudhary (23) S/O-Rajendra Choudhary of Vill- Parbelia Colliery Amdanga all under PS- Neturia, Dist-Purulia and owners of the motorcycles bearing Registration No. WB 82A/6342 and WB 82C/6435 as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S- 188/34 IPC and 51 (1) (b) Disaster Management Act, 2005 and arrange for its investigation.
