Sir,

I, SI Kalyan Kumar Sakha of Neturia PS, Dist- Purulia do hereby lodge a written complaint against (1) Nabani Chakraborty S/O- Lt. Sachhidananda Chakraborty of Neturia (2) Jiten Maji S/O- Lt. Hem Chandra Maji of Bhamuria (3) Kisto Bouri S/O- Lt. Bahadur Bouri of Nabagram of PS- Neturia, Dist-Purulia and 04/05 others to the effect that today on 19.05.2020 while I along with C/78 Utpal Sarkar ,C/584 Madhab Chandra Majee and C/1224 Gajan Murmu all are of Neturia PS as per direction engaged in special mobile duty for implementation of Govt. rules regarding lock down Disaster Management plan. At about 11:00 hrs while we reached at Sarbari More we found that the above noted persons under the banner of SUCI party organized a street corner at Sarbari More under Neturia PS. Accordingly I requested them to stop the said programme but they were running the programme. Later on several request they stopped the programme.

So there is every reason to believe that the above noted accused persons came out from their home and organized street corner at Sarbari More though lockdown is going on throughout the District of Purulia as well as in the state in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 31.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule.


