Sir.

In producing herewith seized articles (1) 480 bottles of whiskey, styled as Royal Stag. (all the bottles are same in size and look having 375ML each. All are in sealed condition.) and (2) 31 Paper boxes and (3) one white colour Mini truck (Pick Up Van) having Rgn No JH10AY/ 7029 I would like to draw your kind attention that, while I was performing my mobile duty along with 1) C/ 1016 Mantu Murmu 2) C/1137 Sridam Bauri and 3) C/ 307 Sasankar Sekhar Bai all of Para PS (vide CC No 1063/2020), at around 17:15 hrs I received a telephonic information from my credible source that one white colour Mini truck (Pick Up Van) having RGN No JH10AY/7029 was going towards Chandankeyari from Raghunathpur side on SH8 and huge quantity of whiskey was being transported by this vehicle illegally. My source also informed me that those whiskey were procured by any fraudulent means or by means of theft and some persons including the owner of the vehicle has been running this business by clandestine manner. Accordingly I informed the matter to you over mobile phone and as per your direction I along with my accompanying force started waiting near Coldi More under Para PS and we blocked the road with the guard rails which are there for traffic purpose. At around 17: 35 Hrs we found one white colour mini truck was coming from Dubra Side and when we gave signal to stop, the driver gradually stopped the vehicle at a distance from us and when we were running to the vehicle, the driver suddenly jumped off from the vehicle and started running. We also ran after him but could not make hold of him. Then we backed to the spot and searched the vehicle. It was the said vehicle for which we were there. On carefully searching huge numbers of Whiskey bottles were recovered. We minutely searched the vehicle but no papers of the vehicle as well as anything else could be found. We recovered total 480 bottles of whiskey styled as Royal Stag from the vehicle. Those bottles were kept in total 31 paper box. We seized (1) 480 bottles of whiskey, styled as Royal Stag. (all the bottles are same in size and look having 375ML each, all are in sealed condition) and (2) 31 Paper boxes and (3) one white colour Mini truck (Pick Up Van) having Rgn No JH10AY/7029 under proper seizure list in presence of my accompanying police force who put their signature on the seizure list. The seizure procedure was done from 18:05 hrs to 20:15 hrs. It is to be noted that no public witness could be made available during seizure as the lock down process is on, generally people don't come out of home as usual.

So, its crystal clear that the owner of the vehicle, the driver and some other persons have been running this illegal business of transporting stolen property in clandestine manner sine long and they are habitual offenders.

Hence I would like to request you to start a specific case against the accd persons (unknown) and arrange for its investigation.
