Sir,

In producing here with 05(Five) arrested accused persons namely 1)Bimal Majee (55yrs) S/o Dhiren Majee of Village- Malanchati, 2) Mahar Kaibartya (29yrs) S/o Madhu Kaibartya of Village- Para, 3) Moriram Bauri (58yrs) S/o Lt- Suchand Bauri of Village- Turradih, 4)Swapan Bauri (35yrs) S/o Krishnapada Bauri of Village-Soyar (Owner of motor cycle No. JH-09AS/3876 TVS Apache), 5) Pasupati Karmakar (38yrs) S/o Lt-Haradhan Karmakar of Village-Soyar all of PS – Para, Dist-Purulia.

I, ASI Mrinmoy Choudhury of Para PS returned to PS with above noted 05(Five) arrested accused persons and brought under seizure above noted 01(One) Motor Cycle to the effect that today (06.05.2020) myself along with force were engaged in mobile duty. During mobile duty as per direction we were engaged for implementation of Govt. rules regarding lock down Disaster Management plan. At 20.15 hrs when they reached at Dubra - Purulia more under Para PS and found that 01(One) motor cycle with 01(One) rider with 02 (Two) pillion riders in the said Motor Cycle was plying in excessive speed as well as other 02(Two) persons were making halla. They tried to intercept themselves and also apprehended them and finally they able to arrest the above noted 01(One) rider and 02(Two) Pillion riders and 02 (Two) others persons. So there is every reason to believe that the rider of said Motor Cycle with 02 (Two) pillion riders as well as 02 (Two) others came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested the above noted 05(Five) accused persons and seized the above Motor cycle with proper seizure list.

Therefore, I pray a specific case may kindly be lodge against 1)Bimal Majee (55yrs) S/o Dhiren Majee of Village- Malanchati, 2) Mahar Kaibartya (29yrs) S/o Madhu Kaibartya of Village- Para, 3) Moriram Bauri (58yrs) S/o Lt- Suchand Bauri of Village- Turradih, 4)Swapan Bauri (35yrs) S/o Krishnapada Bauri of Village- Soyar (Owner of motor cycle No. JH-09AS/3876 TVS Apache), 5) Pasupati Karmakar (38yrs) S/o Lt- Haradhan Karmakar of Village- Soyar all of PS - Para, Dist- Purulia as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated Quarantine rule U/S 188/34 IPC and 54 Disaster Management Act, 2005 and arrange for investigation.
