Sir,

In producing herewith the 02(Two) arrested accused persons namely 1) Chanchal Majhi (29yrs) S/O- Lt. Ambuj Majhi and 2) Mrinmoy Majhi (27yrs), S/O- Dulal Majhi both of Vill- Shyamnagar, PS- Puncha, Dist- Purulia to the effect that today i.e. on 14.05.2020 myself along with force were engaged on Mobile duty vide Puncha PS G.D.E No-511, Dtd-14.05.2020 and CC No-1327, dtd- 14.05.2020. During Mobile duty as per direction we were engaged in implementation of Govt. rules regarding Lockdown and disaster management plan. During Mobile duty at 19:25 hrs at Pairachali market found that the above noted accused persons are moving aimlessly and talking each other violating social distance and lock down order.

In the view of pandemic disease COVID-19, Govt. promulgated Lockdown order and they have to stay at their Home. Knowing all the direction of Govt. they came out from their home and assembled at a place without valid reason and disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measures. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H&FW/120/20 dated 22.03.2020 which is extended till 17.05.2020.

On asked the above noted accused persons did not able to answer satisfactorily for their having been at that place during this time. So, I arrested them after observing all formalities. I offered them bail but at that time none was present there due to lock down.

Therefore, I pray that a specific case may kindly be started against 1) Chanchal Majhi (29yrs) S/O- Lt. Ambuj Majhi and 2) Mrinmoy Majhi (27yrs) S/O- Dulal Majhi both of Vill- Shyamnagar, PS- Puncha, Dist- Purulia as they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/269/270/34 IPC and Sec 51 of National Disaster Management Act, 2005 and arrange for investigation.
