Sir.

In producing here with 03(Three) arrested accused persons namely (1) Samar Mahato (22 Yrs) S/O-Kandarpa Mahato 2) Sanjoy Rajwar(26 yrs) S/O- Lt. Guhiram Rajwar both of Vill- Baragram, PS- Hura, Dist-Purulia and 3) Shibu Rajwar (27 yrs) S/O- Lt. Padmalochan Rajwar of Vill- Basudih, PS- Manbazar, Dist-Purulia along with seized motor Cycle bearing Regn. No WB 56D/7214, seizure list, Memo of arrest & other relevant papers.

I beg to state that today (15.05.2020) morning I was engaged in mobile duty at Puncha market area to find out whether the lock down has been implanted properly at Puncha Market area or not. This refers to Puncha PS GDE No- 538 Dtd. 15.05.2020 and CC No-1334/20 Date-15.05.2020. Accordingly, I had been to market area at about 08:15 hrs and found that the above noted persons with their Motor Cycle, were roaming aimlessly at market area. Myself along with force detained them at Puncha Block morh on Lalpur–Manbazar road under Puncha PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. They were also driving the motor cycle on public way in rush and negligent manner as to endanger to human life. On being asked they did not produce the valid documents in respect of said motor cycle as well as driving license.

Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 & 10/04/2020 for complete restriction measures. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H&FW/120/20 dated 22.03.2020 which is extended till 17.05.2020. Moreover all the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. There was every chance of breach of peace and repeating of offence if not arrested.

Finding no other alternative I arrested them for Disobedience to order duly promulgated by public servant; after maintaining all formalities. Issued Arrest Memo. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. At prima facie there were sufficient grounds to secure their detention. I also seized one Hero Super Splendour motor cycle bearing registration no- WB 56D/7214 under proper seizure list duly signed by the accused persons and witnesses. All the process was done in between 08:25 hrs and 08:55 hrs. I offered them bail but they could not able to produce proper surety.

As there is lock down in the area the peoples left the place and did not agreed to come forward to remain present as witness in the seizure process. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

Therefore, I pray that a specific case may kindly be started against (1) Samar Mahato (22 Yrs) S/O-Kandarpa Mahato 2) Sanjoy Rajwar (26 yrs) S/O- Lt. Guhiram Rajwar both of Vill- Baragram, PS- Hura, Dist-Purulia and 3) Shibu Rajwar (27 yrs) S/O- Lt. Padmalochan Rajwar of Vill- Basudih, PS- Manbazar, Dist-Purulia as they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/269/270/34 IPC and Sec 51(b) of National Disaster Management Act, 2005 and also driving of motor cycle on public way in rush and negligently manner as to endanger to human life U/S 128/129/177/181/184 of MV Act and arrange for its investigation.
