I SI Subhas Malik along with ASI Puspen Ghosh of Purulia (M) PS and C/726 Dipankar Mahato, C/479 Anup Mahato was performing mobile duty in PS area vide C.C. No 1312/2020 Dtd. 07.05.2020 and GDE No 277 Dtd. 07.05.2020. In course of my mobile duty around the Chharrah aerodrome area, while I was moving through Chharrah towards Bhangra More and arrived at the approaching road to Bhangra at 17:05 hrs ,I found the following persons namely 1. Rakhakar Pandey s/o Sudarshan Pandey of Bhangra, 2. Rakesh Mishra s/o Fatik Mishra of Bhangra, 3. Biswajit Roy (Kajal) s/o Sekhar Roy of Karcha, 4. Susamoy Mahato s/o Lt. Satish Mahato of Sitalpur, 5. Kritibas Mahato s/o Lt. Satish Mahato of Sitalpur, 6. Sk Rashid of Chapra, 7. Nanda Pandey of Bhangra & 15 (fifteen) others under the leadership of Rakhakar Pandey blocked the road with some placards and some flags of BJP and was showing agitation on the road in protest of the arrest of Sankar Mahato who has been arrested at Jhalda PS, Dist- Purulia. Subsequently I informed the matter to you. As per your instruction I asked them to show any permission of the concerned authority but they could not show any. Subsequently, I asked them to call a halt of the programmee but they did not pay heed on my words. Thereafter they concluded the programme at 17:25 hrs approx and dispersed. They assembled on road without the permission of the concerned authority. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. 11 & FW/120/20 dated 22.03.2020 which is extended till 21.05.2020. Subsequently it is pertinent to say that the following persons did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others. As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. 11 & FW/120/20 dated 22.03.2020 and did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others so they can be booked u/s 188/269/270 of the IPC & 51 of the National Disaster Management Act, 2005 and 3 of the Epidemic Diseases Act 1897. So a specific case may kindly be initiated against them and arranged for its investigation.
