

Sub: Request for lodging F.I.R. against Sudha Bauri and others.

Sir,

In producing here with 03 (three) arrested accused persons namely (1) Sudha Bauri (33 yrs) s/o- Lt. Nandalal Bauri of Karpur Bagan, Ward No- 21, PS- Purulia (T), Dist- Purulia (2) Raben Bauri (31 yrs) s/o-Kajal Bauri of Karpur Bagan, Near Mansa Mandir, Ward No-21, PS- Purulia (T), Dist- Purulia (3) Sanjay Gope @ Chhutu Gope (22 yrs) s/o- Nandalal Gope of Jamunabandh Para, Ward No-21, PS- Purulia (T), Dist-Purulia along with seized scooty, seizure list, memo of arrest & other relevant papers.

I beg to state that today (14.05.2020), during NAKA checking duty at Goushala More at about 18:55 hrs I found 01 Scooty was coming dangerously from Karpur Bagan side with 03 persons on it without using head gear and reached at Goushala More. We stopped them with proper signal and asked their identity as well as to produce valid documents in respect of their Scooty. But they failed to produce valid documents in respect of their Scooty.

They disclosed their identity as noted above but cannot give satisfactory answer about their such type of activities and running Scooty dangerously with three persons and without using helmets, they also failed to give satisfactory answer for their such type of movement in indiscipline manner. They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt

I arrested them for disobedience to order duly promulgated by public servant; after maintaining all rules of arrest, issued Memo of Arrest. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. More over they driven the vehicles on public way in rush and negligently as to endanger human

I seized one red colour Honda Grazia Scooty having Reg. No- WB56N 0977 driven by (1) Sudha Bauri (33 yrs) s/o- Lt. Nandalal Bauri of Karpur Bagan, Ward No- 21, PS- Purulia (T), Dist- Purulia (2) Raben Bauri (31 yrs) s/o- Kajal Bauri of Karpur Bagan, Near Mansa Mandir, Ward No-21, PS- Purulia (T), Dist-Purulia (3) Sanjay Gope @ Chhutu Gope (22 yrs) s/o- Nandalal Gope of Jamunabandh Para, Ward No-21, PS-Purulia (T), Dist-Purulia.

All the process was done in between 19:15 hrs and 20.05 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present as witness in the seizure process. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 279/188 IPC & Section 51 in the National Disaster Management Act, 2005 & 128/129/177/181/184 M.V. Act.
