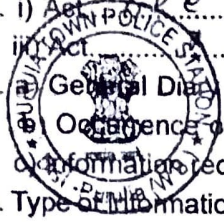

Sir,

I, SI Maniur Rahaman, of Purulia (T) PS do hereby lodged complaint against (1) Nishi Kanta Mehta s/o- Not known of Radha Krishna More, PS-Purulia (T), Dist- Purulia, (2) Babu Chatterjee s/o- Not known of Manbazar, PS- Manbazar, Dist- Purulia, (3) Md. Mujibar Rahaman s/o- Not known of Tamna, PS- Purulia (M), Dist- Purulia, (4) Sri Hari Mahato s/o- Not Known of Nadiha, F.B. Today (15.05.2020) at about 14:15 hrs I have received a source information that the above noted persons are organized a protest at Kachari More near D.M. Office Gate No-1 under Purulia (T) PS with party flag and posters, on demand of (1) Ration should be supplied to all people except Govt. employees, (2) Rs. 8000/- should be paid to every poor people by Central Government and etc. Myself alongwith force reached at 14:25 hrs on the spot, it was observed that the above noted accused persons organized a protest on the above noted subject without any permission. I requested them not to violèt the Govt. order during this pandemic situation of Covid-19. But they do not care my words, even they did not maintain social distance and as well as to break the lock down system. As per Govt. circular, the political programme irrespective of all political parties is restricted in this pandemic situation. Moreover all the persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society and give provocation to the people to break public peace or to commit other offence making conspiracy. They also disobeyed the Government Order regarding recent pandemic situation for attacking of Corona virus throughout the India as well as whole World.

As such they have violated section 188/504/120B/34 IPC & Section 51 in the National Disaster Management Act, 2005.

So I request you for starting a case and also for arranging its investigation.
