Sir,

With due respect, I, SI Sourav Kanti Das of Santaldih Police Station, beg to submit that today (15/05/2020) at about 20:05 hrs, while myself along with force were performing evening mobile duty and found the above noted persons were assembled aimlessly near Chakbad (Birshachak) morh under Santaldih P.S. Police party detained them near Chakbad (Birshachak) morh and being asked they could not able to give any satisfactory answer for their presence at said place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-I (A) Date - 24/03/2020 and further modified dated - 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. Moreover, all the detained persons were refused to comply the direction given by the Central Govt. & State Govt. to combat the rapidity of COVID - 19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, they were arrested after maintaining all formalities regarding arrest and prepared arrest memos and brought them to PS.

Under above circumstances, I, therefore, pray, that a case U/S 188/269/270/34 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005 may kindly be initiated against (1) Khalid Akthar Ansary (25), S/O Nasiruddin Ansary of Belkura, (2) Gobardhan Gorain (31), S/O Rameswar Gorai of Kanki Bosti and (3) Ramesh Bauri (36), S/O Lt. Aghani Bauri of Amcharar, All of PS - Santaldih, Dist. - Purulia.
