Sub:- Prayer for lodging FIR against arrested accused (1) Paltu Mahato (45), S/O Lt. Amulya Mahato of Dumurdiha, (2) Dilip Mahato (34), S/O Sankar Mahato of Anantapur, and (3) Sanjoy Sahish (38), S/O Lakhiram Sahish of Madhudih, all of PS – Santaldih, Dist. - Purulia .

With due respect, I, SI Biswajit Murmu of Santaldih Police Station, beg to submit that today Sir, (16/05/2020) at about 19:45 hrs, while myself along with force were performing mobile duty and found the above noted persons with one black colour Hero Passion Pro Motor cycle bearing Reg. No. JH-09AB-5749, were moving aimlessly at Paharigora more under Santaldih PS. Police party detained them at Pahariogra More on Raghuathpur - Chandankiyari road under Santaldih P.S. and being asked they could not able to give any satisfactory answer for their movement on road and public place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-I (A) Date - 24/03/2020 and further modified dated - 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. Moreover, all the detained persons were refused to comply the direction given by the Central Govt. & State Govt. to combat the rapidity of COVID - 19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, they were arrested and seized the said (JH-09AB-5749) motor cycle under proper seizure list and duly signed by the witnesses and the accused persons, after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to PS.

Under above circumstances, I, therefore, pray that a case U/S 188/269/270/34 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005 may kindly be initiated against (1) Paltu Mahato (45), S/O Lt. Amulya Mahato of Dumurdiha, (2) Dilip Mahato (34), S/O Sankar Mahato of Anantapur, and (3) Sanjoy Sahish (38), S/O Lakhiram Sahish of Madhudih, all of PS - Santaldih, Dist. - Purulia.
