Sir,

In producing herewith one arrested accused Mantu Bauri (34), S/O Taru Bauri of Chelyama, Bagdi Para, PS - Raghunathpur, Dist. - Purulia, driver of the Tractor styled as Mahindra B275-DI, without Reg. Number and bearing Eng No:- RKK2EAN0115 & Chassis No:- MBNABAEXKKRK01572, fitted with trolley (without number plate) loaded with Sand approx 100 Cft. without any Cover & without royalty /Challan was proceeding through Ichhar - Ushir road. I, ASI Dharamdas Rajak of Santaldih P.S. lodged a written complaint to the effect that today (22/05/2020) at about 16:25 hrs., in course of my evening- mobile duty at Ushir village area, I, found the above noted tractor loaded with sand was proceeding towards Ushir village, I, stopped the tractor at Ushir village more with a view to verify the documents but the driver of the said tractor failed to produce any documents against the respective vehicle, his driving licence as well as the loaded sand and to carry the same in the tractor. On interrogation he confessed that, he procured the loaded sand from illegal quarry (Khadan), situated at Damodar River near Ichhar village under the direction of and in connivance with owner, with a view to illegal gain through black marketing. On interrogation driver also stated that he is in habit to run such illegal sand business since long. So they are involved in against quantum of sand violating West Bengal Mines and Minerals Rule 2002 in habitual manner. Therefore I, seized the offending tractor along with fitted trolley loaded with illegal sand under proper seizure list and arrested the accused driver Mantu Bauri (34), S/O Taru Bauri of Chelyama, Bagdi Para, PS - Raghunathpur, Dist. - Purulia at 17:15 hrs.

Hence, I, pray, that a specific case U/S 379/411/413/120B IPC & 21 (1) (4) of WB Mines & Minerals (Regulation & Development) Act -1957, may kindly be started against the driver of the tractor i.e. Mantu Bauri (34), S/O Taru Bauri of Chelyama, Bagdi Para, PS - Raghunathpur, Dist. - Purulia, (driver of tractor) and the owner of the said offending tractor and other involved persons under proper section of Law and to arrange for it's investigation.
