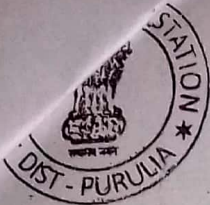


Sir,

I ASI Gurucharan Sahis and along with force C/557 Ambuj Mundal and NVF-960 Rajib Singh Sardar while my night patrolling duty that today on 08/05/2020 at 02:35 hrs. received a credible source information that a Truck bearing registration No-BR44G7524 is coming from Raghunathpur side via Raghunathpur-Saltora road (SH-8) loaded with coal which has been procured by means of theft or any fraudulent means by 1)Amit Kumar Shaw C/O Late Omprakash Shaw of Shihu Bagan, Raniganj Dist. Paschim Bardhaman 2) Phani Bhusan Maji S/O Manindranath Maji of Babu Para near girls college, Searsol Rajbari, PS-Raniganj, Dist- Pachim Bardhaman, 3) Jai Prakash Singh of Rani Sahar more PS-Raniganj, Dist- Pachim Bardhaman. Accordingly, I along with force (C/557 Ambuj Mundal and NVF-960 Rajib Singh Sardar) placed Naka at Rambhattadih More under Santuri P.S . in order to verify the information after obtaining kind permission from O/C Santuri PS. At about 03:15 hrs. found that one Truck is coming from Raghunathpur side. Seeing Police party near Rambhattadih morh the driver of the said vehicle stopped the vehicle on road and fled away in the dark side. After searching it could be ascertained that the said vehicle having registration No- BR44G7524 (12 Wheeler), Engine Srl. No. 61C84290418, Chassis No. MAT466429GHC04351 is loaded with coal (approx 15 (fifteen) Ton. Neither any papers in respect of vehicle nor Coal could be found from the said vehicle. I think that 1)Amit Kumar Shaw C/O Late Omprakash Shaw of Shihu Bagan, Raniganj Dist. Paschim Bardhaman 2) Phani Bhusan Maji S/O Manindranath Maji of Babu Para near girls college, Searsol Rajbari, PS-Raniganj, Dist- Pachim Bardhaman, 3) Jai Prakash Singh of Rani Sahar more PS-Raniganj, Dist- Pachim Bardhaman, Owner of said vehicle (BR44G7524), driver of the said truck (BR44G7524) collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gain and habitual to run this business. Under proper seizure list I seized the aforesaid Truck having its registration No- BR44G7524 loaded with coal approx. 15(fifteen) M.Ton. Then I, sealed & labeled approx 01 (One) K.G. coal as sample coal from major contraband. After that, I brought that seized vehicle loaded with coal at Santuri PS compound.


