I do hereby lodge a complaint against approx 100 male unknown miscreants to the effect that today (12.05.2020) at 15:15 hrs during my mobile duty received information from Duty officer of Santuri Police Station that in ADA office, Santuri Block at Muradi some unknown miscreants of the adjacent villages entered in the office with the demand of vermi compost. When ADA denied to distribute then all miscreants tried to take away the packets of vermi-compost fertilizer illegally and forcefully. On being restrained by the ADA Santuri, the trespasser gheraoed and harassing the ADA Santuri Block. Over this to work out the information I ASI Rabindranath Basak and JC/1061 Debashis Mondal, NVF/913 Rajib Mahato left for the spot. On reaching the spot it is noticed that ADA Santuri is gheraoed and harassed by some unknown miscreants and some other miscreants are carrying the packets of vermi-compost fertilizer from the godown of ADA office. We rescued ADA Santuri. Later we stopped the miscreants to carry the packets of vermi-compost and requested to leave the official compound of this government office and also requested to maintain the social distance during this lock down tenure. Over this the miscreants get angry and started pelting stones and bricks on us and also using filthy languages. We tried our level best to manage the situation. I loudly commanded the said unlawful assembly with the help of loud speaker to disperse. But, they did not pay any heed to my request and command. At this point of time we all to gather chase the mob by raising our lathi at about 15:55 hrs and the mob showed some inclination to retreat and some of them fell down own on the rocky surface and when we tried to get at them in the mean time they also fled away. Accordingly, I stop chasing. We searched the miscreants in the adjacent areas but to no good. After waiting few minutes, we left the spot and arranged our medical treatment at Muradi BPHC. We get some physical injury on our person with the pelted stone, bricks.

Hence, on return to PS, I am submitting a complaint against approx 100 unknown male miscreants to start a specific case in appropriate section of law and also to prevent police in discharging in lawful duty.
