Sir,

With due respect I beg to submit before you that on 17.05.2020 at about 19:15 Hrs while I along with force of Santuri PS was on area round duty, found following persons were gathered at Madhukunda Bazar near Railway station entry gate and gossiping at the spot without maintaining any social distance and without any mask. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road. As such the following persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India vide Order No- 40-3/2020-DM-I(A) dated- 15th April, 2020 to 17th May 2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested from 19:25 Hrs. to 20:05 Hrs. after maintaining all formalities regarding arrest. I also offered them for medical treatment but they stated that they have no necessities for the same. Thereafter, I brought them to P.S.
