Sir,

With due respect and humble submission, I beg to submit that I SI Biswarup Roy along with C/330 Banamali Soren and NVF/768 Shiblal Majhi both of Santuri PS while performing mobile duty on 18.05.2020 at 13:15 hrs received a credible source information that a tractor bearing registration No. WB37D/6387 loaded with coal which has been procured by means of theft or any fraudulent manner is proceeding towards Baranti village from Madhubanpur village side through village metal road. After receiving the said information we have started NAKA checking duty near Baranti Dam under our P.S jurisdiction with a view to intercept the said vehicle. At about 13:35 hrs we found the aforesaid vehicle is coming from Dulurdi village side and seeing police party at near Baranti Dam gate the driver of the said vehicle flee away by stopping the vehicle on road. We have tried to apprehend the driver but failed. On reaching near said tractor I along with my accompanying force searched the vehicle and found that the tractor was carrying 07 MT (approx) coal. No such document could be found in respect of said coal loaded tractor. It is reasonable to believe that the owner, driver of said vehicle bearing Regn No-WB37D/6387, Engine No. 3100FL83B704411F3, Chassis No. MZJSG712129SM with coal loaded Trolley and others collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gains and habitual to run this business. So, I have seized the said tractor (bearing Regn No- WB37D/6387, Engine No. 3100FL83B704411F3, Chassis No. MZJSG712129SM with coal loaded Trolley) under proper seizure list. I have also sealed & labeled approx 01 (one) K.G coal as sample from the major contraband. There was no such public witness available at the time of seizure. Thereafter arranging a public driver I brought the seized tractor loaded with coal at Santuri P.S compound.

I therefore pray before you to lodge a specific case against the owner, driver of the tractor bearing Registration No. WB37D/6387, Engine No. 3100FL83B704411F3, Chassis No. MZJSG712129SM with coal loaded Trolley and others under proper section of law.
