Electricity (Amendment) Act-2007.

On dated 10.01.17 at about 11:20AM, Sri Bijan Guari, Station

at the premises of Khandu Karmakar, Kate Paru Karmakar of  
Ichadi, P.O Bishri, Dist - Manbazar,  
and inspected his/her premises and found that he was enjoying  
electricity unauthorisedly by direct hooking from WBSEDCL's LT line

During inspection, theft of electricity was found, i.e., he/she was using electricity  
unlawfully U/S 135(1)(a) was detected. It was also found that he/she was using the following  
electrical equipments -

- 1) One 60W bulb (1X60)Watt
- 2) One Table Fan (1X60)Watt
- 3) One TV (1X60)Watt
- 4) Two core cable with 3 pin switch board and hooking device

from which we seized the following -

- 1) Two core cable with 3 pin switch board
- 2) Hooking device
- 3) One 60W bulb

The seizure list is prepared as per list and the accused person refused to sign in the  
seizure list. The inspection team left the above premises at about 11:30AM on dated  
10.01.17. The accused person has committed offence U/S 135(1)(a) of the Electricity  
(Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action  
should be taken as per rule.
