Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Bhendranath Mahato S/O- Ambuj Mahato of Village- Behadib, P.O- Bishri, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 10.01.17 at about 11.40AM, Sri Bijan Guari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Bikrami Tudu, SAE (E), Manbazar CCC
- 2) Gomenath Kaha LM, Manbazar CCC
- 3) Gopenath Mahato TSH, Manbazar CCC
- 4)

entered the premises of Bhendranath Mahato S/O- Ambuj Mahato of Village- Behadib, P.O- Bishri, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity by direct hooking from WBSEDCL's LT line unauthorised

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) one 60W bulb (1x60W)
- 2) Three CFL bulbs (3x20W)
- 3) Two nos Fan (2x60W)
- 4) 15 mtr single core cable and hooking device

out of which we seized the following -

- 1) one 60W bulb
- 2) 15 mtr (15m) single core cable
- 3) hooking device

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 11.50AM on dated 10.01.17. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
