Karan Singh Laya of vill - Purudih, P.O - Nekre P.S. Balarampur, Dist - Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his mustered field by direct hooking from the nearby L.T.O.H line of WBSEDCL.

Acting upon such information today on 16/01/2017 in between 1.20 Pm to 2.25 Pm I alongwith Sri Anup Mondal, SAE(E), Sri Arindam Chatterjee, OE and contractor personnel of Balarampur CCC inspected the premises of Sri Amar Singh Laya and held raid.

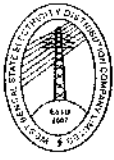
During raid and inspection it was detected that accused Sri Amar Singh Laya is using the electricity dishonestly by making direct hooking from the nearby LTOH of WBSEDCL for running one Centrifugal Monnet Pump for watering the mustered field. having connected Load 0.75 Kw/1 HP. As the incident occurred in an open field no notice was served to the accused, who is not a consumer, also.

I prepared inspection report in presence of the witnesses and assessed the load as 0.75 KW. Details have been mentioned in the inspection sheet.

I directed Sri Anup Mandal, SAELE to disconnect the hooking line from our LTOH line. Accordingly Sri Mandal disconnected the aforesaid hooking line from LTOH line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list. Local people witnessed the incident but refused to sign on the seizure list except of one Lakshman Singh Laya. His LTI was captured by me on the seizure list. A copy of the seizure list was handed over to the accused. For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
