Dear Sir,

I, Sri Sibdas Ball aged 27 years, son of Sri Dilip Kumar Ball, Station Manager Saltore Customer Care Centre, WBSEDCL do hereby lodge complaint against Sk Alamgir, S/o- unknown of Vill. Mamdang, Po-Digha, Dist-Purulia, claimed as relative of Sk Majil, a bonafied consumer of WBSEDCL bearing consumer id:242137086 for giving strong obstruction to discharge official duty of public servant

I, being the Station Manager of Saltore Customer Care Center directed M/S-Ranjit Nandy (WBSEDCL Enlisted Contractor) to disconnect the service lines who did not paid the energy bills as per norms of WBSEDCL. As per direction the representative of M/S-Ranjit Nandy (1) Sri Mrityunjoy Mahata (2) Purna Chandra Majee, (3) Raban Bauri went to disconnect the service connection of one Sk Majil bearing consumer Id:-242137086 with outstanding dues of Rs:-2513/-.

The above said representative of contractor M/S-Ranjit Nandy reported that some obstruction has been faced during performing disconnection work on 17.01.2017 at about 14:30 Hrs at the premises of Sk Majil. Mr. Alamgir and others used slanged towards the said representative and man handled Sri Purna Chandra Majee, and also threatened that if any legal action has been taken "Toderke Pis Pokete ket Pokete nie ghure berabo".
