

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that BIRBAL RAJWAR, S/O- Haladhar RAJWAR of Village-BAGALMARI, P.O.- BAGALMARI, P.S.-PARA, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) & 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 10.02.2017 at about 11.40AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Avishek Das SAE(E) of Dubra Para CCC, Sanjoy Prasad TSH of Dubra Para CCC, Bhaktipada Mahato TSH of Dubra Para CCC, Anandamoy Roy Gr.-I TSH and other staffs of Dubra Para CCC, WBSEDCL inspected the premises of BIRBAL RAJWAR, S/O-Haladhar RAJWAR of Village- BAGALMARI , P.O BAGALMARI, P.S.-Para, Dist Purulia WBSEDCL. During inspection it was found that the said BIRBAL RAJWAR was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 1 no Heater, and 01 no bulb i,e; approx load 1.1KW for domestic purpose, which is an offence u/s. 135 (1)(a)& 135 (1)(b)of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 12.10 pm.

As such BIRBAL RAJWAR, S/O- Haladhar RAJWAR of Village-Bagalmari, P.O.-Bagalmari, P.S.- Para, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) & 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
