In producing here with one seized DI pick up van having registration No-WB 37A/6608 (207 DI van), Chassis No-374415LVZ943745 loaded with coal approx 02 pl 1 seems to be steam coal to the effect that today 28/01/17 at about 15:25 Hrs in course of day mobile duty accompanied by C/932 Samiran Dey, C/1246 Shaktipada Mahata and C/373 Wani Bhusan Mahato all of Neturia PS, while performing anti-crime day patrolling duty at Subhash More on Purulia-Barakar road at that time received a credible source information that the above noted vehicle loaded with coal coming from Sarbari side procuring illegally and trying to transport the same to Jharukhamar Raghunathpur side through Purulia - Barakar road in clandestine manner. Limmediately acquainted to 0 to Neturia PS about the information who directed me forthwith work out the information As such myself accompanied with force immediately started Nal a at Subhash More and found that the vehicle coming from Sarbari side. Seeing the police party from a indicatance the driver stopped the vehicle and started to run away. Accordingly we chase thim but he fled away.

On checking it was found that the registration No. of above noted vehicle was matched as given by source and found that huge quantity of raw coal was loaded inside of the vehicle. On preliminary enquiry it could be learnt that owner of the vehicle and driver of vehicle No- WB 37A/6638 were procured the said coal illegally and transporting the same in a clandestine manner to Raghunathpur side.

So, it is reasonable to believe that the above noted accused driver and registered owner of the said vehicle have obtained the said coal by any fraudulent means and trying to dispose the same coal in a clandestine manner to Jharukhamar Raghunathpur side at per their habitual practice.

So, I seized above noted DI pick up van having registration No- WB 37A/6636 (207 DI van), Chassis No- 374415LVZ943745 loaded with coal after preparing proper seizure list duly signed by the accompanied police person as there was no availability or any local person, as such I could not collect the signature of the local people in the seizure list.

Therefore, I pray that a specific case may kindly be registered against the registered owner and driver of DI pick up van having registration No. WB.37A/66.3.2 [207 DI van], Chassis No-374415LVZ943745 under proper section of law.
