

Sub: Complaint against Ghaltu Kumar S/O- Lt. Ranjit Kumar of Vill.- Tentlow, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46(a) B.E. Act.

Respected Sir,

In producing here with one arrested accused person namely Ghaltu Kumar (60 yrs) S/O- Lt. Ranjit Kumar of Vill. - Tentlow, P.S.- Balarampur, Dist. Purulia along with seized 17 (seventeen) sealed country sprit bottles (DIL KHUSH) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 16:15 hrs I received a credible source information that one person namely Ghaltu Kumar S/O- Lt. Ranjit Kumar of Vill.- Tentlow, P.S.- Balarampur, Dist. Purulia is carrying country sprit without any valid license at Bansgarh Hospital more area under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Bansgarh Hospital more to work out the source information and held raid at Bansgarh Hospital more.

During search with the help of accompany force, we found that the said person is carrying country sprit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of carrying and keeping of said country sprit, Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46(a) B.E. Act and supply one copy to him. Then, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 10 (ten) liters & 200 ML country sprit has been seized, total value of the said seized sprit is Rs- 510/= (Five hundred & ten only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46(a) B.E. Act against the arrested accused person namely Ghaltu Kumar S/O- Lt. Ranjit Kumar of Vill.- Tentlow, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
