Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Grangadhar Murnu S/O- Balaram Murnu of Village- Mudikhal, P.O- Jitujuri P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 17.02.17 at about 2:15PM, Sri Bijan Suari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Bikram Tudu SAE (E), Manbazar CCC
- 2) Somenath Laha LM, Manbazar CCC
- 3) Shyamal Rajak Hg. TSH, Manbazar CCC
- 4)

entered the premises of Grangadhar Murnu S/O- Balaram Murnu of Village- Mudikhal, P.O- Jitujuri, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity by direct hooking from WBSEDCL's LT line unauthorisedly.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Bulb (100W) - 2 nos
- 2) CFL (20W) - 2 nos
- 3) Fan (60W) - 2 nos.
- 4)

out of which we seized the following -

- 1) APPROX 8mtr each single core two wire (Red & black)
- 2) Hooking device
- 3) One bulb with holder (100W/H)

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 02:35PM on dated 17.02.17. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
