Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Grangadhan Murmu S/O Balaram Murmu of Village- Mudikhal, P.O- Jitijuri, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 17.02.17. at about 2:15PM I, Sri Bijan Guari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Bikram Tudu SAE(E), Manbazar CCC
- 2) Somenath Laha LM, Manbazar CCC
- 3) Shyamal Rajak Hg. TSH, Manbazar CCC
- 4)

entered the premises of Grangadhan Murmu S/O Balaram Murmu of Village- Mudikhal, P.O- Jitijuri, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity by direct hooking from WBSEDCL's LT line unauthorisedly.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Bulb -(100W) - 2nos
- 2) CFL (20W) - 2nos
- 3) Fan (60W) - 2nos.
- 4)

out of which we seized the following -

- 1) APPROX 8mtr each single core two wire (Red & black)
- 2) Hooking device
- 3) One bulb with holder (100watt)

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 02:35PM on dated 17.02.17. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
