in producing herewith the accused persons namely (i) Tesimuddin Ansari @ Chhotu (21) S/O- Moniruddin Ansari @ Gobinda of village Dumurhir, FS-Neturia, Dist-Purulia (ii) Abedin Ansari (23) S/O- Hikmat Ansari of Keliasota, P3-Neturia, Dist-Purulia under arrest and seized articles (1) Cannabis/Ganja-22.5 Kg (2) Black Colour big size bag (3) A blue colour TVS Apache motorcycle bearing registration No- WB 82A/4734 (4) 100 gram cannabis/Ganja in brown paper taken from above amount as sample -1 (5) 100 gram cannabis/Ganja in brown paper taken from above amount as sample -2 under proper seizure list, seal and label duly signed by witnesses and the accused persons, 1 SI Rajat Choudhary O/C Neturia PS do hereby lodge complaint to the effect that today (01/02/2017) at 13:15 hrs received a telephonic information from a reliable source that two drug paddlers are likely to go to Chirkunda in a blue colour motorcycle vide registration No- WB 82A/4734 in order to sale cannabis/Ganja to drug addicts illegally violating the provisions of section 8 of the NDPS Act 1985. The reliable source also informed that the pillion rider possess one black colour bag in the middle of the seat of the motorcycle in which the said cannabis/Ganja is kept concealed. I noted the fact in the GD vide Neturia PS GD Entry No- 14 Dt. 01/02/17, informed the matter to CI Raghunathpur, SDFO Raghunathpur and other superior officers and myself along with SI Nimai Ch. Patra, ASI Purnendu Chandra, ASI Bidhan Ch. Mondal, C/86 Gurudas Goswami, and C/1192 Raicharan Maji left for Jhanka More near Kali Mandir vide CC No- 263/16 Dt. 01/02/17 by Govt. vehicle No- WB 56C/8993 to introduce Naka checking on Sarbari-Chirkunda road with Gala, seal, weighing instruments and other accessories. On arrival at Jhanka More near Kali Mandir at about 14:05 hrs started Naka checking there by placing guard rails and briefing the officers and force properly. At about 15:05 hrs, during Naka checking one motorcycle having pillion rider is found coming from Sarbari side. While the motorcycle came nearer, the registration No. of the same was found WB 12A/4731. I alerted the officers and force and intercepted the said motorcycle. One black colour big bag loaded with goods was found on the seat of the motorcycle. I along with force detained them with the said bag. On being asked they disclosed their identities as above. On thorough interrogation they also confessed that the bag contained ganja and they are going to Chirlanda (Jharkhand) side to sale the same to the drug addicts. Then I informed the matter to CI Raghunathpur, SDPO Raghunathpur and other superior officer to be remain present at the spot. As per their direction I also contacted BDO Neturia over telephone to be remain present to guide the search and seizure as per provision of section 50 NDPS Act 1985. Accordingly I contacted BDO Neturia over telephone who told me that he is coming shortly. At about 15:45 hrs BDO Neturia, CI Raghunathpur and SDPO Raghunathpur reached at the spot. Meanwhile, I with the help of officers searched for public witnesses and the witnesses (i) Mahesh Das (41) S/O- Lt. Sukdev Das of Parbelia Amdanga, PS-Heturia, Dist-Purulia and (ii) Pijush Kanti Dasgupta (48) S/O- Fanchanan Dasgupta of Parbelia Colliery, PS-Neturia, Dist-Purulia were subsequently reach at the spot and on

request became ready to assist us in conducting search and seizure, myself served notice U/S-91 Cr PC to both the accused persons in writing whether they are agreed to search their person in presence of Executive Magistrate. They agreed to search their person by a Executive Magistrate and gave their consent in writing. On being asked in writing whether they are willing to search our person before get them searched. Accordingly, they conducted search of our persons but got nothing except our official belongings and prepared nil seizure list. Then I with the help of officers and force searched their persons and the articles belonging to them under the supervision of BDO Neturia, CI Raghunathpur, SDPO Raghunathpur and the public witnesses. During search of the black colour big bag which they were carrying in the motorcycle, a large quantity of Cannabis/Ganja are found inside it. On weighing it was found weighing about 22.5 kg. The Cannabis/Ganja is a prohibited narcotic drugs which they jointly carrying for transportation violating section 20 (b) (i) / 29 NDPS Act, 1985. There is no question of possessing any license for carrying the same accordingly I arrested them. Informed them grounds of arrest, prepared memo of arrest and maintained all formalities. I also seized the said amount of Cannabis/Ganja under a proper seizure list after taking 02 (two) samples each measuring 100 grams from the same, black colour big size bag and a blue colour TVS Apache motorcycle bearing registration No- WB 82A/4734 from their joint possession duly signed by the witnesses as well as the accused persons. Prepared labels of the same and sealed the Cannabis/Ganja along with sample in pre, ence of the witnesses. The total process of arrest, search & seizure, sealing & labeling were done between 15:45 hrs and 17:15 hrs under direct supervision of BDO Neturia, CI Feghunathour and SDPO Raghunathpur.

Accordingly, I started this case Suo-motu against the accused persons namely (i) Tesimuddin Ansari @ Chhotu (21) S/O- Moniruddin Ansari @ Gobinda of village Dumurhir, PS-Neturia, Dist-Purulia (ii) Abedin Ansari (23) S/O- Hikmat Ansari of Reliasota, PS-Neturia, Dist-Purulia under section 20 (b) (i) / 29 NDPS Act, 1985 and directed SI Kousik Banerjee for its regular investigation.
