Sir,

In producing herewith the seized vehicle(Dumper) bearing registration No. JH16B/4018 loaded with approx 10(Ten) ton steam coal. Fact of the case in brief is that today i.e 20.02.2017 at 10:45 hrs acting on tip off myself along with force had been to Ketlapur morh. When we reached at Ketlapur morh found that the above noted vehicle was coming from Kargali side. We stopped the said vehicle at Ketlapur morh on Cheliyama-Dubra pitch road at about 11:15 hrs. Seeing the Police party the driver of the said vehicle left the vehicle there and fled away. We chased him but could not able to intercept him. I searched the said vehicle and found that the said vehicle bearing registration No. JH16B/4018 is loaded with approx 10 ton steam coal. I further searched the vehicle to find out any valid documents in respect of the loaded coal as well as the vehicle but no any papers could be find out. As such there is every reason to believe that the driver and owner of the vehicle bearing registration No JH16B/4018 with ill motive are transporting steam coal illegally and they are running such type of clandestine business since long. They are habituated to run such type of business. So they are liable for offence punishable U/S 379/411/413/414 IPC. Finding no other alternative I seized the dumper bearing registration No JH16B/4018 loaded with approx 10 ton steam coal under proper seizure list in presence of my accompanied staff as there were no other public witness at that time.

Therefore I pray before you that a case against driver and owner of vehicle bearing registration No JH16B/4018 may kindly be started and arrange for its investigation.
