Respected Sir,

In producing here with one arrested accused person namely Monsa Gorai (36 yrs) S/O- Bhim Gorai of Vill.- Rangadih, P.S.- Balarampur, Dist. Purulia along with seized 35 (thirty five) sealed country sprit bottles (DIL KHUSH) 600 ML each (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 20:25 hrs I received a credible source information that one person namely Monsa Gorai S/O- Bhim Gorai of Vill.- Rangadih, P.S.- Balarampur, Dist. Purulia is carrying country sprit without any valid license near Berma Check Post under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force reached of this place to work out the source information and held raid near Berma Check Post.

During search with the help of accompany force, we found that the said person is carrying country sprit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of carrying and keeping of said country sprit. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C)B.E. Act and supply one copy to him. Then, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 21 (twenty one) liters country sprit has been seized, total value of the said seized sprit is Rs- 1050/= (One thousand & fifty only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Monsa Gorai S/O- Bhim Gorai of Vill.- Rangadih, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
