In producing here with arrested accused persons namely 1) Samser Ansari @ Gera (23) S/O- Sahid Ansari of Dumurhir, PS-Neturia, Dist-Purulia, 2) Taiab Ansari @ Lokhu (32) S/O- Babu Ansari of Ränipur, PS-Neturia, Dist-l'urulia, 3) Sabir Ansari (23) S/O- Jakir Ansari of Naragoria, PS-Neturia, Dist-Purulia und 4) Suvan Ansary @ Suvna S/O Jakir Ansary of vill- Dumurhir, PS- Neturia, Dist- Purulia; to the effect that today 02.02.17 at about 00.35 Hrs in course of night mobile duty accompanied with ASI Abu Akher, ASI Purnendu Chandra, C- 932 Samiran Dey, C- 448 Subhankar Mondal and C- 841 Chanchal Pramanik all of Neturia PS at Harmaddih side. At that time received a credible source information that a gang of dangerous dacoits being armed with deadly weapons assembled at nearby Mekatala rail gate and preparing Themselves for committing dacoity on Purulia - Barakar road upon running vehicles. As such myself accompanied with force immediately proce ded to the anticipated place of assembly at 00.55 hrs to work out the information and reached near to the auticipated place at 01.25 Hrs leaving the Police vehicle No WB 56C/8993, led on ambush being led by the source and noticed that 05/06 persons assembled at an open field by the side of Mekatola rail gate and those persons are whispering for preparing themselves to commit decoity upon running vehicles on Puru in - Barakar Pitch road as it could be audible from the talks of the assembled criminals. We watched them from 02.05 hrs upto 02.25 hrs and cordoned them. Then after disclosing our identity, I commended them to surrender but they paid no heed to it and started to run away. We succeeded in rounding up only 04 (Four) of them at 02.45 H_\odot while the rest 02/03 escaped away despite hot chase after them. The arrested pursons disclosed their identity as mentioned above. We searched the above noted accused persons and recovered one country made pipe gun, length approx 26 cm with wooden butt from the left side waist of Samser Ansari @ Gera and one round live 8 mm ammunition from his right side pocket, one bhojali, length approx 45 cm with 10 cm wooden butt from the left side waist of accused Suvan Ansary @ Suvna and one iron rod from accused Taiab Ansari @ Lokhu and another iron rod from the possession of accused Sabir Ansari and also seized two motorcycles having registration No- JH 10 \S/9914 (Ignitor) and JH 10W/2559 (Bajaj Discover) in between 03.05 hrs to 04.10 Hr; on 02.02.17 from the place of assembly of the accused persons. Then, I arrested them and seized one country made pipe gun with one round live 8 mm ammunition, one biojali and two iron rod and two motorcycles from their possession under proper strizure list duly signed by arrested accused persons and witnesses as Alamat property in c/w this case. On interrogation arrested accused persons stated that they have assembled there for committing road dacoity but they could not say about the name of other co - accused persons, During search and seizure I have tried to procure public witnesses to put down signature in the seizure list but the time is dead hour of night so no any person monitable there. Under such circumstances it is reasonably believed that the above

noted accused persons were assembled there for committing road dacoity on Purulia – Barakar road in between Mekatola rail gate – Harmaddih, a course of arrest, I prepared arrest memo, inspection memo and seizure list at the apot after observing all formalities of arrest rule and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against arrested accused persons namely 1) Samser Ansari @ Gera (23) S/O- Sah d Ansari of Dumurhir, PS-Neturia, Dist-Purulia, 2) Taiab Ansari @ Lokhu (32) S/O- Bebu Ansari of Ranipur, PS-Neturia, Dist-Purulia, 3) Sabir Ansari (23) S/O- Jakir Ansari of Naragoria, PS-Neturia, Dist-Purulia and 4) Suvan Ansary @ Suvna S/O Jakir Ansary of vill-Dumurhir, PS- Neturia, Dist-Purulia along with 02/03 others under proper section of law.
