Sir,

I, SI Uttam Kumar Mandal (48) S/O Nishakar Mandal, now attached to Manbazar PS, do here by lodge a complaint against accused namely (1) Swapan Bouri and (2) Mahadev Bouri both S/O - Madan Bouri of village Sonardanga, P.S.- Manbazar, Dist. - Purulia to the effect that today (21.03.17.) at 18:15 hrs. in course of my special raid duty at Indkuri, Manbazar, I received a telephonic information from a reliable source that Swapan Bouri and Mahadev Bouri of Sonardanga village were making oozing liquor illegally and selling the same to hike price for their personal gain. Then myself along with ASI Santosh Singh Sardar, C/595 Tulsidas Hansda and C/549 Nagendranath Mahato rushed to the spot for raid by Govt. vehicle. At about 18:45 hours myself along with force reached at Sonardanga village and raided the house of Swapan Bouri and Mahadev Bouri and found 05 Nos. plastic container there each containing 15 litres (approx.) oozing liquor (illegally distilled liquor), thus in total 75 litres (approx.) Swapan Bouri and Mahadev Bouri along with their family members fled away seeing the police party taking the advantage of darkness. We could not search out them in spite of our tremendous effort. During enquiry local people informed us that Swapan Bauri and Mahadeb Bauri prepare such illegally distilled liquor for last two months and as they do not have any licence of papers in support of such preparation, hence they fled away. Accordingly I seized 05 Nos. plastic containers each containing 15 litres (approx.) of oozing liquor (illegally distilled liquor) under proper seizure list duly sign by the accompanying police persons as the local people assembled there during search and raid refused to sign the scizure list.

I, therefore, request you to start a specific case against the above noted accused persons namely (1) Swapan Bouri and (2) Mahadev Bouri both S/O – Madan Bouri of village Sonardanga, P.S.- Manbazar, District Purulia under BE Act and to arrange for its investigation.
