I do hereby lodge complaint against Sk Tajabul S/o Fakir of Village: Nimdanga Ps- Neturia , Dist: Purulia committed for theft of energy meter u/s 136 (1) (a) of IE Act 2003 duly amended on 2007.

As information gathered from our meter reader Sri Pranay Kr Kabi !, along with 1) Sri Suman Banarjee, Sr. SAE, Raghunathpur Division, WBSEDCL, (2) Sri Indrajit Mahato, Office Executive, Raghunathpur Division, WBSEDCL, (3) Sri Gotirmoy Dass , SAE (E) , Saltore Customer Care Center entered into the premises of Sk Tajabul S/o Fakir of Village: Nimdanga Ps- Neturia , Dist: Purulia on today i.e. 08.02.2017 at about 13:40 Hrs for inspection of electrical installation. During Inspection it has been found that the energy meter (Bearing SI No: BR028850, Make Bentec) has been taken away from the premises. As per office record the meter was installed in that premises on 25.06.2015 and last reading was taken on 15.11.2016. The service was disconnected from pole side on 26.11.2016 due to non-payment of energy bill. The inspection team left the premises at about 14:05 Hrs.

Due to this incident our WBSEDCL has sustained loss of Rs. 1249/- (approx).

Therefore Sk Tajabul S/o Fakir of Village: Nimdanga Ps- Neturia , Dist: Purulia is committed an offence u/s 136 (1) (a) of IE Act 2003 duly amended on 2007.

You are being requested to investigate the matter and take appropriate steps in this regard please.
