Respected Sir,

In producing here with one arrested accused person namely Sanjay Nandi (31 yrs) S/O- Ashok Nandi of Vill.- Sagma, P.S.- Balarampur, Dist. Purulia along with seized 19 (Nineteen) sealed country sprit bottles (DIL KHUSH) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 16:05 hrs I received a credible source information that one person namely Sanjay Nandi S/O- Ashok Nandi of Vill.- Sagma, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license at Sagma Namo Para, under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Sagma Namo Para to work out the source information and held raid at Sagma Namo Para.


During search with the help of accompany force, we found that the said person is selling country sprit (DIL KHUSH) bottles. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country sprit (DIL KHUSH). Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S- 46A(C)B.E. Act and supply one copy to him. Then, I seized all the sealed country sprit (DIL KHUSH) bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 19 (Nineteen) Bottles country sprit (DIL KHUSH) has been seized, total value of the said seized sprit is Rs- 570/= (Five hundred & seventy only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Sanjay Nandi (31 yrs) S/O- Ashok Nandi of Vill.- Sagma, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
