In producing herewith one arrested accd. person namely Raju Kuiry (36 yrs) S/O- Anadi Kuiry of Vill- Para Kuiry kuli, PS- Para, District - Purulia with seized articles (1) 37 (Thirty Seven) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml (2) 05(Five) pcs of empty bottles styled as "DIL KHUSH" which were seized under proper seizure list.

I beg to submit that today (06.03.2017) during evening mobile duty in between 21:15 hrs and 21:45 hrs acting on a tip off a raid was conducted in tea shop of Raju Kuiry (36 yrs) S/O- Anadi Kuiry of Vill- Para Kuiry kuli, PS- Para, District - Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in tea shop. On demand he failed to produce any valid document in respect of keeping and selling of liquor from the tea Shop. As such I arrested him and also seized (1) 37 (Thirty Seven) sealed bottle of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml (2) 05(Five) pcs of empty bottles styled as "DIL KHUSH" under proper seizure list in presence of witnesses duly signed by them.

The above noted arrested accd. namely Raju Kuiry (36 yrs) S/O- Anadi Kuiry of Vill- Para Kuiry kuli, PS- Para, District - Purulia committed offence u/s 46 A(c) B.E.Act. 1909 for unauthorized possession and sale of country spirit in his tea Shop.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Raju Kuiry(36 yrs) S/O- Anadi Kuiry of Vill- Para Kuiry kuli, PS- Para, District - Purulia and arrange for its investigation.
