7... That thereafter I informed the S.P. Purulia on 19.12.2016 about the incident but till today the Police person could not take any action though they assured to take action against the accused person.

Hence it is therefore prayed that your Honour would be pleased to sent his petition to the O/C Manbazar P.S. as per U/S 156(3) for investigation and treat this as F.I.
