In producing here with one arrested accused person namely Mithun Saw S/O- Thakur Saw of Balarampur, P.S.- Balarampur, Dist. Purulia along with seized 12 (twelve) sealed country sprit bottles (DIL KHUSH) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 19:05 hrs I received a credible source information that one person namely Mithun Saw S/O- Thakur Saw of Balarampur, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license at own shop near Saraf Petrol Pump under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Saraf Petrol Pump to work out the source information and held raid at Saraf Petrol Pump.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his own shop. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country sprit. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 7 (seven) liters & 200 ML country sprit has been seized, total value of the said seized sprit is Rs- 360/= (three hundred & sixty only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Mithun Saw S/O- Thakur Saw of Balarampur, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
