In producing herewith the accused persons namely (1) KurbanAnsary (30) S/O Lt. SulemanAnsary of Vill- Benadala PO- Gagnabad PS- Adra Dist- Purulia 2) Md. Nasir Ansary (50) S/O Yad Ali Ansary of vill- Metalsahar, Tola- Kuldi, PS Adra Dist- Purulia along with 1) One polythene packet of Cannabis/Ganja weighing 5.430 Kgs., 2) One polythene packet of Cannabis/Ganja weighing 5.220 Kgs., 3) One polythene packet of Cannabis/Ganja weighing 5.230 Kgs., 4) One polythene packet of Cannabis/Ganja weighing 5.380 Kgs., 5) One big size bag having black colour with red colour strip 6) One big size bag of red & navy blue colour, 7) One blue colour TVS Apache motorcycle having Reg. No. WB 82A 9784, under proper seizure list sealed and labeled by me duly signed by the witnesses and accused persons, I SI Mukul Karmakar, O/C Adra Police Station do hereby lodge this complaint suomoto against the above noted three accused persons for committing an offence punishable U/S 20 (b)(ii) C NDPS Act 1985. Today (02.03.17) at 15:25 hrs. received reliable source information that two persons riding on a motorcycle and carrying huge quantity of Cannabis/Ganja will cross Monpura Rly Level Crossing to go to North side Adra for selling the same to local peddlers. My source also informed that 02 (two) drug peddler of Benedala and Metyalsahar area will riding on a blue coloured TVS Apache motorcycle having Reg. No WB 82A 9784 are likely to sale the Cannabis/ Ganja to Adra and Raghunathpur area. The source also mentioned that the motorcycle rider, aged about 30 years, wearing denim jeans & White & Sky full shirt (Square check) & pillion's age about 51 years and wearing Sky colour shirt & gray colour full pant they carrying two big bag in the middle portion of the said motorcycle, both containing packets of Cannabis/Ganja. Accordingly, I noted the fact in G.D. vide Adra PS GDE No 71 dtd 02.03.17 & informed the matter to CI, Kashipur & SDPO, Raghunathpur, and other Superiors Officers of Purulia District. As per their direction, at about 15:35 hrs., myself along with my source & Police Personnel of Adra PS namely SI Sanjib Roy Ghatowal, ASI Giridhari Roy, C/78 Utpal Sarkar, C/1224 Gajan Murmu C/252 Alokbikas Karan vide C.C. No. 759 dtd 02.03.17 & GDE No. 72 Dt. 02.03.2017 left for Manpura jungle near Manpura railway crossing area to work out the information by Govt. vehicle having Reg. No. WB 56 C 8992 also carried seal, gala, match box, candle, brown paper, weighing instrument and kit box.

At about 15.45 hrs reached near Manpura railway crossing and kept the vehicle in a hiding place, we ambushed ourselves at different places with proper briefing. Kept watch at the pacca road approaching towards Manpura Railway Crossing. At about 16.15 hrs one motorcycle rider and one pillion with two big bags were found coming through the jungle path towards Manpura Railway level Crossing. Then we blocked the jungle path and covered the area by placing men from two side. On seeing the Police party they tried to flee away by returning the Motor bike but I along with accompanied officers & force surrounded them & also detained them with the said bags and motor cycle disclosing our identities as Police Officer of Adra PS. We wear proper uniform. On being asked the they disclosed their identity as 1) Kurban Ansary S/O Lt. Sulaman Ansary of Vill- Benadala PO-Gagnabad PS- Adra Dist- Purulia 2) Md. Nasir Ansary S/O Yad Ali Ansary of Vill- Metalsahar, Tola- Kuldi, PS Adra Dist- Purulia who were riding with blue coloured TVS Apache motorcycle having Reg. No. WB 82A 9784 with two Bags containing Cannabis/ Ganja and coming toward the Manpura Railway crossing from jungle side. On interrogation, the said Kurban Ansary also confessed that the both bags contained Cannabis/Ganja. On further interrogation at PO they informed that they will sale the said Cannabis/Ganja to the retailers of Adra and Raghunathpur area. Then I informed the matter to CI, Kashipur and SDPO, Raghunathpur. Thereafter, I issued notice to both accused persons asking them whether they are willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, both detained persons gave their willingness in writing to be searched in presence of an Executive Magistrate accordingly sent requisition to the SDO, Raghunathpur with a request to depute an Executive Magistrate for search and seizure as per provision of section 50 of NDPS Act. Meanwhile, we searched for public witnesses with the help of accompanied officer & force two persons came forward to turn-up as witnesses. Soon CI, Kashipur, SDPO, Raghunathpur & Sri Biswanath Rakshit, WBCS (Ex. Magistrate, Raghunathpur) arrived at the spot and disclosed their identity and explained the reason for arriving over there. After their arrival I started search & seizure process at PO. Then I offered the said detained persons to search our persons before get them searched. Accordingly they conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of Sri Biswanath Rakshit WBCS (Ex. Magistrate, Raghunathpur) and detained persons. Myself with the help of officers and force searched Kurban Ansary and Md. Nasir Ansary at the spot. During search of them, two nos of loaded bags were found. Thereafter as per direction of Executive Magistrate I opened two bags. In each bags found two separate polythene packets containing cannabis/Ganja are found. All the four polythene packets contained in two big bags are opened and found Cannabis/Ganja. On question both the accused persons confessed their guilt saying that their carrying the same to seal the retailer for wrongful gain. Accordingly I seized both big size bags. One having black coloured with red colour strip containing two polythene packets of Cannabis/Ganja weighing 5.430 Kg & 5.220 Kg inside under proper seizure list duly signed by the Police & public witnesses, and accused persons in presence of Executive Magistrate. Another big size red & navy blue colour bag containing separate two polythene packets Cannabis/Ganja inside weighing 5.230 Kg & 5.380 Kg. Also packaged, sealed and leveled the same at the PO with the help of accompanied officers and force and made over one copy of seizure list to the accused persons. Then I conducted I also seized the blue colour TVS Apache motorcycle having Reg. No. WB 82A 9784 under proper seizure list duly signed by the police & public witnesses and accused persons in presence of Executive Magistrate. Also packaged, sealed and leveled the same at the PO with the help of accompanied officers and force and made over one copy of seizure list to the accused person. The Cannabis/Ganja is prohibited narcotic drugs which they were dealing in lieu of money that violating Sec. 20(b)(ii) C NDPS Act 1985. On question they failed to show any valid documents or license for possessing the Cannabis/Ganja. Accordingly I arrested both of them. Informed them ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest. Total process of arrest, search, seizure, sealing and leveling were done in between 17.25 hrs and 18.30 hrs under the direction & presence of Sri Biswanath Rakshit, WBCS (Ex. Magistrate, Raghunathpur, SDPO, Raghunathpur and CI, Kashipur.

I started this case Suo-moto against the accused persons namely (1) Kurban Ansary (30) S/O Lt. Sulaman Ansary of Vill- Benadala PO- Gagnabad PS- Adra Dist- Purulia 2) Md. Nasir Ansary (50) S/O Yad Ali Ansary of vill- Metalsahar, Tola- Kuldi, PS Adra Dist- Purulia U/S 20(b)(ii) C NDPS Act 1985 and directed SI Susanta Kr. Pathak for its investigation.
