Sir,

In producing herewith the arrested accused (1). Subhas Mandal (32Y), S/O-Lt. Sastipada Mandal (2) Kalosona Mondal (26Y), S/O-Tapu Mondal & (3) Bidhan Roy (35Y) S/O-Manik Roy all of Vill-Ghoramurga, PS-Santuri P.O-Marbedia , PS-Santuri, Dist-Purulia & seized items as per seizure list. I, beg to submit that on 19-02-17 in course of evening mobile duty, received a credible source information that some persons were coming from Poradiha side with Bicycle loaded with coal. After brought to notice of my superior and as per direction I, along with force left for Poradiha side to work-out the source information. After proceeding towards the Hansdima to Poradiha pitch road found three person with coal loaded three bi-cycles (approx 08 Quintal coal) coming from Poradiha side near Mohanpur village pitch road. I, stopped them but they tried to conceal but We managed to detain & on being asked they could not produced any valid documents of said coal loaded bi-cycles. On being interrogation they confessed that "they will store up the said coal after received dishonestly as stolen property for aiming concealment to deal for profit".

However we conducted search of the Scene of Crime and seized the following articles as:

(1). Approx 08 (eight) Quintal Steam coal with three bi-cycle. [Seized as Stolen Recovered Articles]

I seized the above articles as stolen recovered property and as in between 20:05 hrs to 20:35 hrs in presence of Police witnesses. I have arranged to bring those seized articles to PS. I have also tried to find out the local locals witnessess but found none since usually none other.

I, therefore pray before you to lodge a specific case against accused namely (1). Subhas Mandal (32Y), S/O-Lt. Sastipada Mandal of Vill-Ghoramurga, P.O-Marbedia, P.S-Santuri, Dist-Purulia & (2) Kalosona Mondal (26Y), S/O-Tapu Mondal of Vill-Ghoramurga P.O-Marbedia, PS-Santuri, Dist-Purulia (3) Bidhan Roy (35Y) S/O-Manik Roy of Vill-Ghoramurga, PS-Santuri P.O-Marbedia , PS-Santuri, Dist-Purulia under section-379/411/414 IPC.
