Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one aced. Person namely Amit Raj @ Pappu (38Y) S/O Lt. Chhattu Raj of Vil+PS- Jamalpur, Dist-Munger, Bihar, A/P-Vill- Amidhowra, PS-Neturia, District- Purulia with seizure of 1) 12 pcs. Sealed bottles of Kingfisher strong premium beer containing 650 ml each, 2) 12 pcs. Sealed bottles of Tuborg strong beer containing 650 ml each, 3) one 750 ml bottle of Imperial Blue whisky containing approx 600 ml, 4) one 750 ml bottle of Macdowell XXX Rum containing approx 500 ml, 5) one 375 ml bottle of Royal Stag whisky containing approx 300 ml 6) one 1000 ml bottle of Blenders pride whisky containing approx 400 ml 7) 25 pcs. Of sealed bottles of Dil se containing 600 ml each which were seized under proper seizure list.

I beg to submit that today (07.03.17) in between 00.35 hrs to 02.15 hrs. a raid was conducted in Sonu hotel of Lagan Pandey S/O Lt. Shakti Pandey of Vill -Neturia, PS-Neturia, District- Purulia situated at Mouza Neturia beside Purulia Barakar pitch road under PS Neturia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted persons were keeping / selling Id. liquor which were kept in his hotel on demand the above noted Amit Raj @ Pappu failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 1) 12 pcs. Sealed bottles of Kingfisher strong premium beer containing 650 ml each, 2) 12 pcs. Sealed bottles of Tuborg strong beer containing 650 ml each, 3) one 750 ml bottle of Imperial Blue whisky containing approx 600 ml, 4) one 750 ml bottle of Macdowell XXX Rum containing approx 500 ml, 5) one 375 ml bottle of Royal Stag whisky containing approx 300 ml 6) one 1000 ml bottle of Blenders pride whisky containing approx 400 ml 7) 25 pcs. Of sealed bottles of Dil se containing 600 ml each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The above noted arrested aced. namely 1) Amit Raj @ Pappu (38Y) S/O Lt. Chhattu Raj of Vil+PS- Jamalpur, Dist-Munger, Bihar, A/P-Vill- Amidhowra, PS-Neturia, District- Purulia and the owner of Sonu hotel namely Lagan Pandey S/O Lt. Shakti Pandey of Vill -Neturia PS-Neturia, District- Purulia have committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of Id. liquor.

It may note here that during raid 1. C/ 1932 Samiran Dey, 2. C/ 230 Ashis Mahadani & 3. C/ 841 Chanchal Paramanik all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against 1) Amit Raj @ Pappu (38Y) S/O Lt. Chhattu Raj of Vil+PS- Jamalpur, Dist-Munger, Bihar, A/P-Vill- Amidhowra, PS-Neturia, District- Purulia and 2) the owner of Sonu hotel namely Lagan Pandey S/O Lt. Shakti Pandey of Vill -Neturia PS-Neturia, District- Purulia under proper section of law.
