Respected Sir,

In producing here with one arrested accused person namely Bhiswa Gorai (60 yers) S/O-Lt. Thakurdas Gorai of vill- Rangadih, P.S- Balarampur, Dist. Purulia along with seized 15 (fifteen) sealed country sprit bottles (Dil Kush) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18.55 hrs I received a credible source information that one person namely Bhiswa Gorai (60 yers) S/O-Lt. Thakurdas Gorai of vill- Rangadih, P.S. Balarampur, Dist. Purulia stocking and selling country sprit without any valid license from his own sweet shop at village Rangadih under Balarampur P.S., Dist.-Purulia. Accordingly, I along with officer & force left for Rangadih village to work out the source information and held raid into the sweet shop of Bhiswa Gorai (60 yers) S/O-Lt. Thakurdas Gorai of vill- Rangadih, P.S. Balarampur, Dist. Purulia. I like to note here that seeing the Police personnel, customers were fled away.

During search with the help of accompany officer & force, we found that the said person is stocking country sprit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country sprit. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him and inform his relatives. Then, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 09 (nine) liters country sprit has been seized, total value of the seized ID liquor is Rs- 450/= (Four hundred fifty only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Bhiswa Gorai (60 yers) S/O-Lt. Thakurdas Gorai of vill- Rangadih, P.S. Balarampur, Dist. Purulia and arrange for its investigation.
