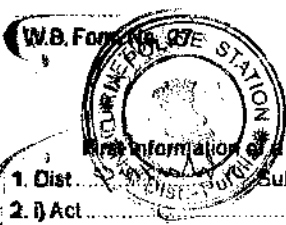

Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Aswini Bauri (56) S/O- Lt. Krishna Chandra Bauri of village Sarbari, PS-Neturia, District- Purulia with seizure of (1) 01 pc. Sealed bottles of officer choice whiskey containing 01 lit., (2) 01 pcs. Sealed bottles of imperial blue whiskey containing 01 lit. (3) 12 Pcs. Of sealed bottles of McDowell No-1 whiskey containing 180 ml each, (4) 10 pcs. Of sealed bottles of McDowell XXX rum containing 180 ml each, (5) 05 Pcs. Of sealed bottles of kingfisher strong beer 650 ml each which were seized under proper seizure list.

I beg to submit that today (07.03.17) in between 20.05 hrs to 21.45 hrs. a raid was conducted in Maa Laxmi hotel of Aswini Bauri (56) S/O- Lt. Krishna Chandra Bauri of village Sarbari, PS-Neturia, District- Purulia situated at Mouza Sarbari beside Sarbari Panchet pitch road under PS Neturia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his hotel on demand Aswini Bauri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 01 pc. Sealed bottles of officer choice whiskey containing 01 lit., (2) 01 pcs. Sealed bottles of imperial blue whiskey containing 01 lit. (3) 12 Pcs. Of sealed bottles of McDowell No-1 whiskey containing 180 ml each, (4) 10 pcs. Of sealed bottles of McDowell XXX rum containing 180 ml each, (5) 05 Pcs. Of sealed bottles of kingfisher strong beer 650 ml which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Aswini Bauri (56) S/O- Lt. Krishna Chandra Bauri of village Sarbari, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C /141 Subhash Ch. Kaibarta, 2. C/ 1119 Susanta Kumar Sinha & 3. C/ 373 Abani Bhusan Mahato all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Aswini Bauri (56) S/O- Lt. Krishna Chandra Bauri of village Sarbari, PS-Neturia, District- Purulia under proper section of law.
