In producing herewith the accused person namely Kunja Sing Babu (20 yrs), S/O-Narsing Sing Babu of Vill+P.O- Tunturi, P.S. Baghmundi, Dist-Purulia along with seized articles 1) 60 (Sixty) ltr (Chullu) ID Liquor containing in 05 (five) Jarican and 05 (five) plastic bottles 2) 06 (six) Plastic glass 3) RS-/175 as sale proceed 4) one empty plastic bottles which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 06.03.17 during the special raid I along with 1. C/601 Shyamlal Mandi, 2. SAP C/880 Dilip Sing Sardar, 3. SAP C/493 Ajoy Kumar Gorai at 14:45 hrs arrived at Tunturi village and a raid was conducted in the house of Kunja Sing Babu (20 yrs), S/O-Narsing Sing Babu of Vill+P.O- Tunturi, P.S.-Baghmundi, Dist-Purulia, acting on a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found the Kunja Sing Babu (20 yrs), S/O-Narsing Sing Babu of Vill+P.O- Tunturi, P.S.-Baghmundi, Dist-Purulia were keeping/ selling Id Liquor (Chullu) which were kept with his possession in his house. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he was arrested U/S- 67 B.E. Act. And also seized 1) 60 (Sixty) ltr (Chullu) ID Liquor containing in 05 (five) Jarican and 05 (five) plastic bottles 2) 06 (six) Plastic glass 3) RS-/175 as sale proceed 4) one empty plastic bottles which were seized under proper seizure list duly signed by the witness U/S-67 B.E. Act. A sample ID liquor (Chullu) taken out as sample and all seized articles were labeled properly inn presences of witness and accused person. During arrest the ground of arrest was duly notified, issued arrest memo U/S- 50 Cr.P.C and handed over a copy of the same to the arrested person.

The above noted arrested accused person namely, Kunja Sing Babu (20 yrs), S/O-Narsing Sing Babu of Vill+P.O- Tunturi, P.S.-Baghmundi, Dist-Purulia committed an offence U/S- 46 B.E. Act. 1909 for unauthorized possession and selling of

ld Liquor (Chullu) from his sole possession in his own house.

Under the fact and circumstances therefore pray a Case U/S- 46 (A) (c) B.E. Act. 1909 may kindly be started against the said accused person namely Kunja Sing Babu (20 yrs), S/O-Narsing Sing Babu of Vill+P.O-Tunturi, P.S.-Baghmundi, Dist-Purulia.
