**Sub:-**Prayer for starting a specific case against namely Biswanath Mahato (34), s/o-Saheb Ram Mahato, vill-Hetjari, PS-Arsha, Dist-Purulia

Sir,

In producing herewith one accused person namely Biswanath Mahato (34), s/o-Saheb Ram Mahato, vill-Hetjari, PS-Arsha, Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1)25(twenty five) sealed plastic bottles (CS) containing 600ml each and labelled with DIL KHUSH
- 2)09(nine) sealed (glass) bottle (CS) containing 600ml each and labelled with DIL KHUSH
- 3) Cash rupees 655/- (six hundred & fifty five) as sale proceed
- 4) One yellow nylon bag
- 5) One white big polythin bag

I do hereby lodge this complaint regarding that today 04.01.17 at about 16.35 hrs during my evening mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely in front of his tea stall at Hetjari more under village Hetjari, PS-Arsha. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/985-Lakhinder Tudu, C/414-Biplab Kr Pal, both of SAP 7th Bn camp at Arsha PS, rushed to the spot to work out the information. On arriving to the spot, I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Biswanath Mahato (34), s/o-Saheb Ram Mahato, vill-Hetjari, PS-Arsha, Dist-Purulia after preparing proper memo of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
