

In producing herewith the arrested accused (1). Ratan Mal (30Y), 5/O-Tarapada Mal of Vill+PO-Kalidaha, P.S-Kashipur, Dist-Purulia & (2) Nimai Mahato (48Y), S/O-Late Ratikanta Mahato of Vill+PO-Kalidaha, P.S-Kashipur, Dist-Purulia & seized items, I beg to submit that on 10.01.17 in course of anti crime day mobile duty, received a credible source information that some persons heaped steam coal by receiving illegally at bushy area, in between Ramchandrapur to Sadhusaltora pitch road beside the Kendberia village. After brought to notice of my superior and as per direction I along with force left for P.O to workout the source information. After proceeding towards the P.O & we reached near the bushy area in between Ramchandrapur to Sadhusaltora pitch road beside the Kendberia village as per source information & we found the aforesaid two persons & heap of steam coal (approx 06 MT). On being interrogation they confessed that they have stored up the said coal received dishonestly & concealed it as stolen property for aiming to deal for profit as habitually.

However we conducted search of the Scene of Crime & searched the surrounding the Pits and found and seized the following articles: (1). Approx 06 MT Steam coal which was stored up & concealed as stolen property for habitual dealing. [Seized as Stolen Recovered Articles]

I seized the above articles as stolen recovered property and as in between 15:15 hrs to 15:35 hrs in presence of Police witnesses. I have arranged to bring those seized articles to PS. I have also tried to find out the local witnessess but found none since usually none other.

I, therefore pray before you to lodge a specific case against accused namely (1). Ratan Mal (30Y), S/O-Tarapada Mal of Vill+PO-Kalidaha, P.S-Kashipur, Dist-Purulia & (2) Nimai Mahato (48Y), S/O-Late Ratikanta Mahato of Vill+PO-Kalidaha, P.S-Kashipur, Dist-Purulia under proper section of law.
